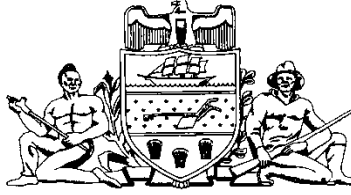

**CJAB Fact –** Since early in the formation of CJAB, integral to its success has been the County’s Department of Information & Technology (IT) Services. Through 2015, the IT Department completed the first round of a plan that worked with local law enforcement and other first responders to meet common goals towards more coordinated data sharing across platforms, among other security and technology improvements. This included grant funded projects such as the CODY COBRA and IN-SYNCH RMS Systems, as well as support on projects such as the Harrisburg City Camera Project. Additionally, early data dashboards were explored in 2015 for the Chief Executives to encompass simple key criminal justice metrics. The importance of IT continues today and is represented in the results of Stepping-Up, RMS platform integrations such as STADIA, and other important initiatives. Their skills and support are essential to ensuring the success of the work we do.
