To All 2025 Municipal Candidates:

The 2025 Municipal Primary Ballot Position Lottery for all offices filing with the Dauphin County Board of Elections in which more than one candidate has filed will be held **Wednesday, March 19, 2025**, in Dauphin County Courthouse Lobby, 101 Market Street, Harrisburg, beginning at 9:00 A.M.

It is not necessary that candidates be present. A candidate may have someone draw in the candidate's place by executing a **letter of attorney** to appoint an agent to draw on their behalf. The letter of attorney must be duly signed by the candidate and either notarized as required by law, or by completing an unsworn declaration. In the absence of a candidate or a duly authorized letter of attorney, the Director of the Bureau of Registration and Elections will appoint a person registered and enrolled in the candidate's party to draw on behalf of the candidate.
