**RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF DAUPHIN COUNTY, PENNSYLVANIA  
AUTHORIZING REFUNDS OR STRIKE-OFFS, AND/OR  
EXONERATION OF COUNTY TAXES PAID OR DUE  
FOR ALL TAX YEARS INCLUDING 2016 AND 2017  
LEVIES TO THOSE CITIZENS AS DEFINED ON  
EXHIBIT 1, HARRISBURG AREA EXPERIENCING  
SIGNIFICANT ISSUES RELATING TO SINKHOLES  
AS OF APRIL 2, 2014**

**RESOLUTION #3-2017**

**WHEREAS**, late in the summer of 2011, successive storms, Hurricane Irene and Tropical Storm Lee, produced near record rainfalls, widespread flooding, and significant damage to residents, businesses, and infrastructure across large areas of Pennsylvania, including Dauphin County; and

**WHEREAS**, the President formally declared both Hurricane Irene and Tropical Storm Lee Federal Disasters on September 3 and 12, respectively; and

**WHEREAS**, Section 239 of the Department of Housing and Urban Development Appropriations Act, 202 (Pub. L. 112-55, approved November 18, 2011) (Appropriations Act) makes available up to \$400 million, to remain available until expended, in Community Development Block Grant (CDBG) funds for necessary expenses related to disaster relief, long-term recovery, restoration of infrastructure and housing, and economic revitalization in the most impacted and distressed areas resulting from a major disaster declared pursuant to the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1974 (42 U.S.C. §5121 *et seq.*). The Appropriations Act requires that funds be used only for specific disaster-related purposes. The law also requires that prior to the obligation of funds a grantee shall submit a plan ("the plan") detailing the proposed use of all funds, including criteria for eligibility and how the use of these funds will address long-term recovery; and

**WHEREAS**, through the Community Development Block Grant Disaster Recovery Assistance Program, Dauphin County, Pennsylvania, has received notice of a direct allocation of funds to address impacts related to the federally declared disasters that occurred in the summer of 2011; and

**WHEREAS**, Dauphin County's general strategy and priorities for evaluating and responding to the most critical and immediate disaster related needs are based on the analysis of post disaster impacts and conditions as described in the needs assessment of the plan; and


**WHEREAS**, the County through the Commissioners have determined that a specific location known as the "South 14<sup>th</sup> Street, Harrisburg" area has experienced significant issues relating to sinkholes as of April 1, 2014 that were likely caused by this natural disaster; and

**WHEREAS**, the County Commissioners deem it appropriate to provide assistance to those citizens within the area that meet the project evaluation criteria of the plan shall be issued refunds or strike-offs of their County taxes paid or due for tax years 2016 and exonerations or refunds for 2017 levies; and


